Structure and management

Paisley Art Institute (PAI) is a charitable, unincorporated organisation. The purpose of the Institute, as recorded in the Constitution dated November 2011, is the encouragement and the promotion of Art by means of exhibitions and occasional lectures, meetings and classes, and the purchase of works of art or literature or by any other means which the committee determines appropriate.

The Charity's Committee of Management formally meets five times a year and includes the post holders of President, Vice-Presidents (2), Secretary, Membership Secretary and Honorary Treasurer. Informal meetings are arranged throughout the year.

Objectives and activities

Committee of Management

At the October 2015 AGM several changes to the Trustees and Committee of Management were proposed and accepted. President Michael Durning stepped down after 4 years in post. President elect, David Sutton, was elected formally as the new President. Vice-President Eslyn Barr was re-elected. Joe Broadley HPAI was elected as a second Vice-President as allowed by the constitution. PAI Secretary, Lindsay Neil BA (Hons) and Membership Secretary, Irene McCann remained in their roles. The Honorary Treasurer, Richard Burgess, remained in post. New committee members were; Nicola Carberry, Alastair Strachan, Brent Morrison, Lisa Watt. These effectively replacing members stepping down from October; Tom Allan MA (Hons) ARBS PAI, Janet Forry BA (Hons), Gillian Price BA (Hons). Michael Durning PPAI PAI RSW remained on the committee.

Events

The historical exhibition: "A Paisley Legacy, The Paisley Art Institute Collection" opened in the Paisley Museum and Art Galleries from 3rd October 2015 and ran until 24th January 2016. The exhibition marked the double centenaries celebrating; the gifting of Galleries 2, 3, 4 and 5 to the PAI; the start of the PAI Collection. Approximately 230 works from the PAI Collection were catalogued and on show along with complementary loan artworks and had not been seen for 42 years. Visitors were recorded by the Galleries' attendants as 3,788 and 256 catalogues were sold. Being of historical interest, unsold catalogues were distributed to libraries, art schools, academic institutions and publishing bodies. There were 57 very positive feedback comments from visitors. There were very few negative comments and one negative comment, recurring from previous exhibitions, is that the artwork numbers (for cataloguing purposes) were too small. This will be addressed for the annual exhibition.

A series of lunch time talks on the PAI Collection were presented by Michael Durning PPAI PAI RSW and were well received.

The 128th **PAI Annual Exhibition** opened on the 14th May 2016 in the Paisley Museum and Art Galleries and ran until 26th June 2016. This continues to be an exhibition open to all artists and not just members of the PAI. Over 500 artworks of paintings and sculptures were submitted and 464 were hung or shown. Again, this represents the largest hanging of a single open exhibition in Scotland in 2016. Eye-catching, bespoke artwork numbers with the PAI logo were produced in response to comments on earlier exhibitions. PAI hosted Corporate and Private View evenings for artists, purchasers and interested members of the public. There were 3,274 visitors to the exhibition including 138 guests to the Corporate Evening and 339 to the Private View. 570 exhibition catalogues were sold throughout the span of the exhibition including the preview evenings. Catalogues were also distributed to sponsors, advertisers and special guests.

The Guest Artist was the well-known Kurt Jackson MA (Oxon) DLitt (Hon) RWA whose work reflects his commitment to the environment and the natural world. Jackson regularly contributes to radio and television and presents environmentally informed art documentaries for the BBC. The Guest Sculpture was Sir John Steell RSA (1804-1891) who was the most eminent and respected sculptor of the Victorian generation. A maquette of one his famous works sited in Edinburgh was kindly loaned to the PAI from the Paisley Museum's collection for the exhibition.

The exhibition was promoted by the production full colour posters using an image from one the PAI Artist Members. This image was also used for the front cover of the 128th catalogue. Publicity and promotion of the exhibition were further advertised through art media organisations, the PAI web site, Facebook and Twitter accounts.

The catalogue was supported by 14 advertisers, some new to working with the PAI. All exhibited works were eligible for 24 awards, mostly from generous, repeat sponsors. Some sponsors and award givers had declined this year but were replaced by new sponsors including two from the Paisley 2021 (City of Culture) Bid Team and one from The McKay Award. The guest external assessors chose works for awards not given by the specific sponsors and comprised Jean Cameron, Director of the 2021 Bid, Justin Currie, singer, James McNaught, art auctioneer and David Howat, solicitor.

The Committee put out a competitive tender to printers for the 2016 annual exhibition catalogue and, based on the quotes, agreed to change printers resulting in significant cost savings but with the same quality over the previous year. Fewer publicity posters were printed and, with a complementary increase in web site and social media publicity, produced effective savings. The Honorary Treasurer also managed to recoup pockets of VAT erroneously charged by some advertisers used for PAI publicity. Sales of small works donated by artist members were down on the previous year but still raised £1,084 after commissions.

The PAI organised a competition for **Primary and Secondary Schools** and was open to all schools in Renfrewshire. The purpose is to encourage emerging talent in art. More active promotion of the competition by new Secretary Lesley Hinde resulted in record entries from 10 Secondary Schools, ranging from S1-S6, and 5 Primary Schools, ranging from P4-P7. From over 200 entries an excellent exhibition of 100 works were hung in tandem with the Annual Exhibition from 21st May to 21st August 2016 and attracted a large number of visitors. The Schools' Exhibition is hung above the main foyer and reception area of the Museum and visitor numbers are not measured directly but, given that 9,599 visitors pass the foyer to gain access to the upper level, it can be assumed that numbers up to this level would have visited the schools' work. The competition was judged by the President, one of the Vice-Presidents and the Honorary Treasurer with the Secretary acting as adjudicator. The generous sponsor, Macfarlane Group, allowed the PAI to present a trophy for the overall winner and 6 prizes over three age categories.

PAI Collection

Gifts to the PAI Collection by three benefactors have been accepted formally by Paisley Museum and Art Galleries (Renfrewshire Leisure) as holders of the Collection. Namely a portrait of JAD Mackean by Maurice Greiffenhagen was gifted by Colin Mackean, a great nephew of Mackean. JAD Mackean was a Vice President and Honorary President of the PAI and a Burgh Treasurer and was a patron of many famous Scottish artists and a private collector. Two pieces of stoneware sculpture were gifted by the long-standing and respected PAI artist member Falconer Houston and his friend Gordon Mabbott. Both pieces, titled 'Paisley' and 'Glasgow' were sculpted by Falconer but the latter was in the possession of Gordon Mabbott.

Loans

Loans of two important works from the PAI Collection were made to The Holburne Museum, Bath, to complement their 'Impressionism, Capturing Life' exhibition which ran from 13th February 2016 until 5th June 2016. The works were 'Road to Deauville' by Eugene Boudin (1824-1898) often regarded as the true father of Impressionism, and an early practitioner of painting 'en plein air', and 'Paisley Lawn Tennis Club' by Sir John Lavery (1856-1901) one of the famous 'Glasgow Boys'.

Intimations

The PAI was informed of the passing of one of our Diplomates, James Spence RSW RGI PAI. He was a cofounder of The Glasgow Group in 1957 and exhibited widely at home, Europe and Russia and attracted many awards over the years.

Financial Review

The Trustees' policy is to maintain sufficient reserves to cover a minimum of three months expenditure, excluding exhibition costs and artist payments. Exhibition costs are met from commission on exhibition painting sales and catalogue sales. Artist payments are only payable on exhibition sales completed and paid.

The Trustees' consider the results for the year ended 31 July 2016 to be satisfactory considering that the major exhibition "A Paisley Legacy, The Paisley Art Institute Collection" was funded from reserves and fund raising activity in the year.

Grants Policy

The charity does not make grants. Awards are made annually on the basis of judging panel recommendations for various categories of art and most of these awards are funded by sponsors.

Risk Statement

The trustees actively consider the risks to which the charity is exposed and where possible, and appropriate, take such actions as are necessary to mitigate those risks.

Statement of Trustees' Responsibilities

It is the responsibility of the trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and the results of the charity for that year. In preparing the financial statements the Trustees are required to:

- select suitable accounting policies and then apply them consistently:
- make judgement and estimates that are reasonable and prudent:
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its business.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity which enable them to ascertain the financial position of the charity and which enable them to ensure that the financial statements comply with the constitution. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other regularities.

3 Basis of accounting

Mary Armour Fund

The artist Mary Armour left £5,000 in her will to be used by the Institute. The Institute presents the William and Mary Armour Award each year at our annual exhibition.

Secretarial fees of £4,417 (2015: £5,192) were paid during the year for administrative duties of which. £3,500 was paid to trustees (2015: £3,667)

Independent Examiner's report

I report on the accounts of the Charity for the year ended 31 July 2015 which are set out on pages 6 to 11.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1) (a) to (c) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
